TO LEVY SPECIAL ASSESSMENTS FOR THE REPAIR OF CERTAIN DESCRIBED SIDEWALKS IN THE VILLAGE OF SMITHVILLE, OHIO, AND DECLARING AN EMERGENCY

BE IT ORDAINED by the Council of the Village of Smithville, Ohio:

SECTION 1: That the assessment of the cost and expense of repairing sidewalks on Summit Street in accordance with Resolution #1993-11, in the Village of Smithville, Ohio, amounting in the aggregate to \$2,193.52 as reported to this Council on the 13th day of June, 1994, notice of the filing of which assessments has been given as required by law, be and the same is hereby adopted and confirmed, and that there be and are hereby levied and assessed upon the lots and lands bounding and abutting upon said improvement the several amounts reported as aforesaid, which assessments and the description of said lots and lands are now on file in the Office of the Clerk of this Council and which assessments are not in excess of the the special benefits, and are not in excess of any statutory limitation.

SECTION 2: The Clerk is hereby authorized and directed to certify the aforesaid assessments to the Wayne County, Ohio Auditor, not later than the 2nd Monday in September, 1994, for collection with other taxes shown upon the tax duplicate for the year 1994 which are collectible during the year 1995, and for the years thereafter as shown upon the record of assessment, the Council finding that all notices required to be published have been published, the time for filing objections has passed and that no objections have been raised against said assessments. All of the landowners, whose interests may be affected by said assessments, may at their option pay same in lump sum within 30 days after passage of this ordinance; and, the owner to be assessed has requested the assessment.

SECTION 3: This ordinance shall take effect and be in force from and immediately after its passage at the earliest time allowed by law.
