Thank you for your assistance in this regard.

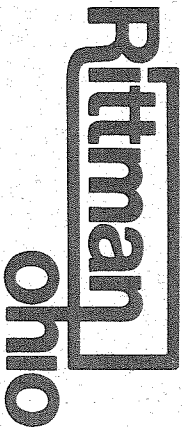
