Certification of Assessments to Wayne County Auditor

Dear Commissioners:

Johnny Appleseed

On August 12, 1992 the Board of County Commissioners authorized through Resolutions 92-425 and 92-437 the creation of special drainage improvement maintenance assessments on certain parcels in Johnny Appleseed Allotment No. 5, located in Franklin Township. Such assessments to build and maintain drainage works on private property are authorized under ORC 6131.63 and 6137.02. The maintenance assessment fund was established by a \$147.30 payment from the developer, with the stipulation that future annual assessments against specific parcels would not begin until their need was established by the County Engineer. I am requesting that you authorize the auditor to begin collecting these assessments to adequately fund future maintenance projects.

On June 28, 1995 the Board authorized through Resolution 95-343 the creation of maintenance assessments on certain parcels in The View at Hunters' Crossing (Phase II), located in Wooster Township. This maintenance fund was established by a [Redacted] payment from the developer for Tax Year 1994, with the stipulation that the initiation of annual maintenance assessments on the specific parcels for future tax years would begin immediately.

Please certify the attached assessment schedules for these projects to the auditor so that they can be collected beginning with the January 1996 billings.
