

Insecure, and/or Unsafe Structure Owned Bradley A. Fath Located at 2467
Shreve Road, in Wooster Township, Wayne County, Ohio.**

It was moved by Trustee Lindeman and seconded by Trustee Ogden, that the following resolution be adopted:

PREAMBLE

WHEREAS, the property located at 2467 Shreve Road (the "Property"), Wooster Township, Wayne County, Ohio 44691 (the "Township"), and currently owned by **Bradley A. Fath** (the "Owner"), is burdened by a neglected structure with open and/or broken windows and other points of entry (the "Structure"); and

WHEREAS, on or around October 15, 2020, the Wooster Township Fire Department, through its Fire Chief, Chris Shook (the "Fire Chief") and Mr. Russ Arters, Chief Building Official, Wayne County Building Department, declared the Structure to be insecure; and

WHEREAS, pursuant to the provisions of Ohio Revised Code Section 505.86, the Board of Trustees of Wooster Township, Wayne County, Ohio (the "Board") is authorized to provide for the removal, repair, or securance of any structurally defective, insecure, and unsafe buildings or other structures within the Township; and

WHEREAS, pursuant to the provisions of Ohio Revised Code Section 505.86, prior to the removal, repair, or securance of any insecure, unsafe, or structurally defective building or other structure, the Board is required to give notice to the owner and lienholders of record of its intent to remove, repair, or secure the structure, and provide an opportunity to the owner and lienholders of record to request a hearing in writing within thirty (30) days after receiving such notice; and

WHEREAS, it is in the best interest of the Township and its residents to proceed under the provisions of Ohio Revised Code Section 505.86 in order to remove, repair, or secure the structurally defective, insecure, and unsafe Structure located on the Property.

PREAMBLE

WHEREAS, the Wooster Township Fire Department has found a building located on the property at 2467 Shreve Road, County Parcel No. 56-01311.000 (the "Structure"), Wayne County, Ohio in the unincorporated area of Wooster Township, Wayne County, Ohio, 44691 (the "Property") to be structurally defective, insecure, and unsafe pursuant to the provisions of Section 505.86 of the Ohio Revised Code; and

WHEREAS, pursuant to Section 505.86 of the Ohio Revised Code, the Wooster Township (the "Township") Board of Trustees (the "Board") is authorized to remove, repair, or secure a structurally defective, insecure, and unsafe structure after notice to the property's owners and lienholders of record of the Board's intention to secure such structure if the owner fails to remove, repair, or secure the structure or make arrangements for such corrective measures within thirty (30) days from the date of said notice; and

WHEREAS, on or about March 29, 2021, pursuant to Resolution No. 2021-3-15, the Township notified the owner of the Property, Bradley A. Fath and lienholder(s) (if any) of the Board's intention to secure the Structure if the structurally defective, insecure, and unsafe conditions of the Structure were not corrected, and that the Owner had the right to request, within twenty (20) days of the date of said notice, a hearing before the Board to be heard and to determine whether or not the Board would proceed to secure the Structure.

WHEREAS, on or as of the twentieth day, April 18, 2021, the Owner and lienholder(s), if any, failed to request said hearing, and, to date and to the Board's knowledge, no corrective actions have been taken or arrangements made at this time with respect to the securance of the Structure; and

WHEREAS, it is in the best interests of the Township and its residents to proceed under Section 505.86 of the Ohio Revised Code in order to secure the insecure, unsafe and structurally defective Structure located on the Property.




