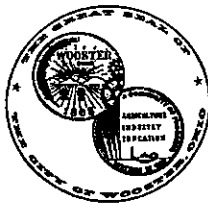

The total amount to be certified is \$72,197.38.

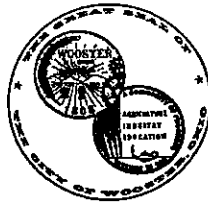
