Dear Jarra -

Please certify to the property tax duplicate (first half) 2019 for *164 Church Street, Doylestown. Parcel #17-00864.000, Owner Bruce & Kathleen Worcester*, \$744.09 for a violation of Section 1333.01 of the codified ordinances of the Village of Doylestown.

1333.01 KEEPING DOWN WEEDS.

(a) The owner having the care of any lot or land within the Village shall cut down and remove therefrom all offensive and noxious weeds, vines and grass of a height of eight inches or more and any and all weeds, vines and grass constituting a threat to the public health, safety and welfare. (b) It is a prima-facie violation of this chapter if weeds eight inches or more in height exist on any lot between May 1 and October 1. (c) The Village Zoning Inspector or designee of the Mayor shall cause annual notice to be published in the Village Newsletter and posted on the Village Website notifying residents of the requirement of this chapter. (Ord. 2014-15. Passed 5-7-14.)


1333.05 WRITTEN RETURN TO COUNTY AUDITOR; LIENS.

Council shall make a written return to the County Auditor of their action under this chapter, with a statement of the charges for their services, the amount paid for labor, the fees of the officers serving the notices, and a proper description of the premises. These amounts, when allowed shall be entered upon the tax duplicate and be a lien upon such lands from and after the date of entry and be collected as other taxes and returned to the Village with the General Fund.
